Current Rural Saver Plan customers will automatically receive the increased minutes from 120 to 240 per month.

The Rural Saver Plan was designed to help RESIDENTIAL customers in rural areas to call the county seats and immediate areas around their home communities at a discounted rate. The Rural Saver Plan now provides up to 240 minutes a month for **only \$1.49, and includes calls to areas within a 41-mile circle.\*** If you currently subscribe to the Rural Saver Plan your minutes will automatically increase from 120 to 240 minutes a month. ## National Do-Not-Call Registry

NATCO maintains the highest standards of ethical conduct in all its marketing activities and is committed to complying with all federal and state law.
